Order

In terms of Government of India Order no. 40-3/2020-DM-I(A) dated 01/05/2020 lockdown period has been further extended for another 2(two) weeks with effect from 04/05/2020. In this regard, it is hereby clarified that following additional activities over and above allowed in the previous orders largely pertaining to essential goods and services are permitted from 04/05/2020 **outside the containment zones all over the state:**

1. Intra district bus services within the districts in Green Zones only with 20 passengers or upto 50% seating capacity at a time, which ever is less. Buses should be disinfected regularly and it must be ensured that all the passengers wear masks. Operational routes within the district shall be decided by District Magistrates of the respective districts. In no case, these buses shall cross district boundaries.

2. Stand-alone shops (single shop in any area /locality/residential neighbourhood) from 10:00 AM to 6:00 PM.

3. Neighbourhood shops related to Hardware, Laundry, Mobile and Mobile recharging, Electronics, Garments & Textiles, Books, Stationery, Paint and Varnishing, Electrical Appliances, Electric Goods, Tyre & Tubes, Batteries, Motor Vehicle Repair and Spare Shops etc including such items mentioned in attached Annexure I are allowed to operate from 10:00 AM to 6:00 PM. Sweetmeat shops can remain open upto 6 PM.

4. Tea and Pan Shops for only take away purpose will remain open from 10:00 AM to 6:00 PM. However, *no gathering shall be allowed near these shops.*

5. Industrial activities with prior permission for which request may be sent by email to cs-westbengal@nic.in.

6. Mining activities in Green and Orange Zones including transport of materials to permitted work sites.

7. All construction activities in rural areas.

8. In -situ construction activities where workers are available on site in urban areas with prior permission of District Magistrates / Commissioner, KMC.



9. Private offices can operate from 10 AM to 6 PM with upto 25% strength.
10. Movement of private cars for permitted activities will be allowed with driver plus two passengers.
11. Barber shops and salons in Green Zones only.
12. No activities , other than those allowed as per previous orders, shall be permitted in the shopping malls and market complexes. Provision in respect of market complex/ shopping mall and street vending shall be reviewed and notified later on.
13. Assembly of persons for any activity shall not be allowed in the State. However for any social function, assembly of maximum of 7 (seven) persons shall be allowed following the norms of social distance & health hygiene protocol.
14. Gathering of not more than 7 (seven) persons shall be permitted at a time in banks, post-offices, ration shops and any other shops & establishments allowed under this order.

It is advised that home delivery and work-from-home should be the preferred option as far as possible. Norms of social distancing and health & hygiene protocols should be strictly followed. Wearing of masks will be compulsory.

Any violation of this order shall attract penal action under the provisions of Disaster Management Act,2005.
