NOTIFICATION

Whereas, as per Order No. 549-CS/2021/141-Health, dated-15/06/2021 of the Chief Secretary to the Govt. of West Bengal local hotspots and pockets of high incidence of Covid-19 cases are required to be declared as containment or micro-containment zones and special steps are to be taken for containment of further spread of the Covid-19 infection,

Whereas, the Block Development Officer, Matiali Development Block, Jalpaiguri sent proposal for declaration of containment zone, vide his letter under Memo. No. 750/BDO/MAT, dated-22/06/2021 in the areas of Matiali Batabari-I GP of Matiali Development Block under the district of Jalpaiguri; where high incidence of Covid-19 cases has been found,


Hence, as per prescribed parameters as stated in above order, the below mentioned areas are hereby declared as **Containment Zones**:

Affected Area (Containment Zone)	Matiali Block	Matiali Batabari-I G.P.	13	Mahabari Bus Stand to Subhas Chhetri house through Mahabari Deopani Primary School & Rajib Lama house to Ganesh Mandir via Nepali Primary School at Mahabari

The CMOH, Jalpaiguri is requested to take up all health related containment measures, in the above mentioned areas as per existing guidelines. He is also requested to take up early testing, tracing and tracking of suspected cases for better clinical management of such cases.

The Superintendent of Police, Jalpaiguri is requested to take up all measures for effective enforcement of the containment steps. Strong surveillance measures must be instituted in the containment zone by the Block level Task Force. Norms of physical distancing and Covid appropriate behavior must be strictly enforced in the areas.

This order will take immediate effect and remain in force until further order.


