NOTIFICATION

Whereas, as per Order No. 549-CS/2021/141-Health, dated-16/06/2021 of the Chief Secretary to Govt. of West Bengal local hotspots and pockets of high incidence of Covid-19 cases are required to be declared as containment or micro-containment zones and special steps are to be taken for containment of further spread of the Covid-19 infection,

&

Whereas, B.D.O, Bhatar/Burdwan-I/ Burdwan-II/ Galsi-I/ Purbasthali-I, and SDO, Kalana have sent proposal for declaration of containment zones, in the G.P areas of Block and Ward areas of Municipality respectively as enclosed herewith, falling under the jurisdiction of Purba Bardhaman District where high incidence of Covid-19 cases has been found,

Now, therefore in exercise of the power conferred upon the undersigned vide the order of the Chief Secretary, Government of West Bengal vide Memo No. 549-CS/2021/141 – Health dated : 15/06/2021 the areas of Purba Bardhaman District as enclosed in Annexure are hereby notified as “Broad / Micro Containment Zones” in terms of Order No. 351/HS/PA/20 dated : 07/07/2020 of the Additional Chief Secretary, Home & Hill Affairs, Government of West Bengal.

All directives & clarification in respect of the prohibitions, general advisory & restrictions for the notified area as enclosed herewith will remain applicable.

The CMOH, PurbaBardhaman is requested to take up all health related containment measures, in the above mentioned areas as per existing guidelines. He is also requested to take up early testing and tracking of suspected cases for better clinical management of such cases.

The Superintendent of Police, PurbaBardhaman is requested to take up all measures for effective enforcement of the containment steps. Strong surveillance measures must be instituted in the containment zone by the Block level Task Force. Norms of physical distancing and Covid appropriate behavior must be strictly enforced in the areas.

This order will take immediate effect and remain in force further order.




