

- 3) Applicant should be submitted self attested Xerox copy of head office or branch office address at Malda Town or in the area of Chanchal Sub-Division with repair License certificate for easily communication as required for maintaining work of Weigh Bridge.
- 4) All intending eligible company / contractor / agency will have to enclose their experience certificate / credential certificate on similar nature of work with their sealed quotation. Only last two financial years credential certificate will be accepted (date will be calculated from 1<sup>st</sup> April'2020 to till date.)
- 5) The interested person / Company should be quoted their rate both in figure and in ward in his own hand writing including all taxes.
